Dear Madam/Sir

I would like to request you to refer to my letter dated 26th April, 2018 (copy enclosed) regarding Direct Benefit Transfer through NSAP-PPS under National Family Benefit Scheme (NFBS) vide which you were informed that NFBS has been on-boarded DBT Bharat portal and the scheme has become DBT compliant. DBT Bharat is the online portal of DBT Bharat Mission and is being centrally monitored by the Prime Minister's Office on monthly basis.

2. Under the current dispensation, further release of funds for NFBS are contingent upon following the steps provided in my aforementioned letter. In this regard, the data entry status under NFBS is enclosed herewith. As it is evident from the Data Gap report as on 28.05.2018 (copy enclosed), the States/UTs have not yet begun digitizing the data of claimants under NFBS. The digitization and payment facility under NFBS on NSAP-PPS has been online and functional now for a month. As informed earlier, the interface for entering details of applications sanctioned offline i.e. legacy cases where payments have already been made to the beneficiaries will be open till 30th June, 2018 under respective log-ins of the State/District/Sub-districts.

3. I would request all States/UTs to expedite the data entry of legacy data in order to bridge the data gap between number of claims settled under NFBS during 2017-18 and digitized data under NFBS. It is also requested to initiate DBT on a monthly basis so that the claimants get the relief on time. It is also requested to push all payments under NFBS through NSAP-PPS i.e. on www.nsap.nic.in which is linked with DBT Bharat portal for central monitoring.

As you are aware that National Family Benefit Scheme (NFBS) is one of the centrally sponsored schemes under NSAP. Under the objective to make NFBS DBT compliant, the scheme has now been on-boarded DBT Bharat Portal with "B10AN" as DBT scheme code.

2. As a second step for making NFBS DBT compliant, a work flow based interface has been developed on NSAP PPS for processing online applications and is functional. Following steps are to be followed in the process:

- Details of deceased persons and claimants to be entered through the respective log in of States/Districts/Sub-districts on NSAP PPS.
- Applications are received and details of the deceased and the claimant with his/her bank/postal account and Aadhaar details are to be entered at Sub district level. An application number will be generated at this stage and an acknowledgement slip will be given to the claimant.
- Aadhaar will be authenticated on the fly with UIDAI and the status of linkage of verified Aadhaar with bank/postal account will also be fetched from NPCI simultaneously.
- The application will be visible to verifying authority for verification at sub-district level.
- The verified applications will then be visible to the sanctioning authority for approval, sanctioning of applications, and generating of sanction order for payment to the claimant.
- Facility for tracking of application status will also be provided on NSAP homepage under 'More Reports' for use by the Applicant.
- The interface for entering details of applications sanctioned off line i.e legacy cases where payments have already been made to beneficiaries will be open till 30th June 2018 under respective log in of States/Districts/Sub-districts.

3. As you are also aware that NSAP PPS is already integrated with PFMS and provides end to end solution for digital transactions. All entitled payments under NFBS from F.Y 2018-19 onwards are to be transferred to claimant's bank/postal account only through ABP/NEFT on NSAP PPS under PFMS code '3166'. Payments through cash/Money Order are to be strictly avoided.

4. All State/UTs are to mandatorily use NSAP PPS for transfer of benefits to ensure uniformity in following DBT mode in respect of NFBS scheme. I would like to request you to personally look into the matter and expedite the implementation of DBT in NFBS from F.Y. 2018-19.
