Please refer to the Secretary's (Rural Development) D.O Letter Number Q.14016/1/2019-AI(RD) dated 27th May, 2019 regarding New India 2022- 75 Milestones for India @75 and Performance Review Committee(PRC), which is scheduled to be held on 06th and 07th June 2019 at Hall no.5, Vigyan Bhawan, New Delhi.

2. I would also like to apprise you that Secretary (RD) in his letter also mentioned that New Governments priorities are 75 Milestones which are to be achieved by 2022 (copy of presentation enclosed).

3. The milestones set for NSAP schemes (social security) among 75 milestones to be achieved by 2022 and other issues on which the review would be focused have already been brought out in the said D.O. letter. However, the following policy issues emanating from 75 Milestones would be taken up during the meeting of Performance Review Committee (PRC) Meeting:-

I. Policy Prescription : Social Security

Action Required : (a) Revamping of NSAP by expanding and increase pensions by using SECC data
(b) Comprehensive social security for unorganized labourers and marginal & small farmers including insurance/pension

II. Policy Prescription: Convergence

Action Required: Skill development opportunities for differently able and for young widows – work already started under DDUGKY/RSETI

III. Policy Prescription: Good Governance

Action Required: (a) Adoption of PFMS platform for NSAP schemes
(b) Social Audit/ Public Grievance Mechanism

IV. Other Issues:

(a) Opening of Separate nodal accounts for NSAP schemes
(b) Release of funds for 2019-20.
(c) Door step delivery of pension on monthly basis

4. It will be highly appreciated if you can send a one page on the above policy matter highlighted as per 75 milestones.
