Dear Colleague,

The National Annual Awards function of the Department of Rural Development, Government of India is scheduled on 19th of December, 2019. Do also communicate to the Secretary, looking after Pradhan Mantri Gram Sadak Yojana (PMGSY) and National Social Assistance Programme (NSAP) to enable their participation in this meeting.
